Reporting Procedures for Observed or Supposed Misconduct

- Discuss suspicious behavior **immediately**. Please report any concerns to your ministry leader. Any inappropriate conduct or relationships between an adult volunteer and a minor should be confronted immediately and investigated.
- Oklahoma law requires anyone who has reason to believe that a child is being abused must report the suspicion promptly to DHS. Failure to report suspected abuse is a crime. No person, regardless of their relationship, is exempt from reporting. A person reporting in good faith is immune from both civil and criminal liability.
- You do not need a disclosure, only a suspicion or a concern of any degree.
